Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.    Durden Banking Company, Inc. does not share with our affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.    Durden Banking Company, Inc. does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.    Durden Banking Company, Inc. doesn't jointly market.	

## **Other Important Information**

For Alaska, Illinois, Maryland and North Dakota Customers. We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization.

**For California Customers.** We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization. We will also limit our sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us.

**For Massachusetts, Mississippi and New Jersey Customers.** We will not share personal information from deposit or share relationships with nonaffiliates either for them to market to you or for joint marketing - without your authorization.
